

Richfield Town Board Budget Workshop

The Richfield Town Board held a 2021 budget workshop on October 6, 2020 in the Richfield Town Garage. The meeting was open by Supervisor Palevsky at 6:02 pm. Board members present were Eckler, Bello, Frigault, and Seamon. Highway Superintendent Proctor and Clerk Young were also in attendance.

Motion by Frigault to increase revenue line A3005 from \$12,500 to \$15,000, second by Seamon. Bello-yes, Eckler-yes, Frigault-yes, Seamon- yes, Palevsky-yes.

Motion by Eckler to increase revenue line A2610 from \$15,000 to \$20,000, second by Frigault. Bello-yes, Eckler-yes, Frigault-yes, Seamon- yes, Palevsky-no.

Motion by Eckler to increase A1110.1 from \$11,250 to \$11,750, second by Seamon. Eckler withdrew his motion.

Motion by Eckler to increase A1111.1 from \$15,000 to \$17,500. With no second, the motion failed.

Motion by Seamon to increase A1111.1 from \$15,000 to \$16,000, second by Eckler. Bello- no, Eckler-yes, Frigault-no, Seamon- yes, Palevsky-no. Motion not moved.

Motion by Palevsky to increase A1680.1 from \$0.00 to \$375, second by Frigault. Bello- yes, Eckler-yes, Frigault-yes, Seamon- yes, Palevsky-yes.

Motion by Bello to increase A7230.4 from \$4,000 to \$11,000, second by Frigault. Bello- yes, Eckler-no, Frigault-yes, Seamon- yes, Palevsky-yes.

Motion by Frigault to increase DA5140.4 from \$1,200 to \$1,700, second by Seamon. Bello- yes, Eckler-yes, Frigault-yes, Seamon- yes, Palevsky-yes.

Motion by Seamon to increase DA5142.1 from \$95,000 to \$110,000. With no second, the motion failed.

Motion by Bello to increase DA5142.1 from \$95,000 to \$105,000, second by Eckler. Bello- yes, Eckler-yes, Frigault-yes, Seamon- yes, Palevsky-abstain.

Motion by Seamon to increase DA5142.4 from \$50,000 to \$65,000, second by Eckler. Bello- yes, Eckler-yes, Frigault-yes, Seamon- yes, Palevsky-no.

Motion by Seamon to increase DB5110.1 from \$91,000 to \$97,500. With no second, the motion failed.

Motion by Eckler to increase DB5110.4 from \$60,000 to \$100,000, second by Frigault. Bello- yes, Eckler-yes, Frigault-yes, Seamon- yes, Palevsky-no.

Supervisor Palevsky suggested using fund balance to fund the increases made to the budget. Frigault stated, as long as we do not go below six months of operations.

Motion by Frigault to move the 2021 Tentative Budget to the 2021 Preliminary Budget with the above changes made, second by Palevsky. Bello- yes, Eckler-yes, Frigault-yes, Seamon- yes, Palevsky-yes.

Motion by Frigault to schedule a public hearing for the 2021 budget on October 19, 2020 in the Richfield Town Garage, second by Palevsky. Bello- yes, Eckler-yes, Frigault-yes, Seamon- yes, Palevsky-yes.

Motion by Palevsky to cancel the pending cut to the Highway Departments HSA and fund it 100%, second by Frigault. Bello- yes, Eckler-yes, Frigault-yes, Seamon- yes, Palevsky-yes.

Motion by Eckler to adjourn at 8:14 pm, second by Palevsky. All members were in favor.
